- I. Welcome/introductions everyone introduced themselves
 - a. Council make-up need attendance for success. Need more outreach to potential council members and current members.
- II. Review of 10/11/12 minutes Tanja O'Brocta motioned, John Buttino second; minutes approved as written
- III. Train the Trainer
 - a. Law enforcement two full days of training
 - i. Training conducted
 - 1. Evaluation summary (attached)
 - 2. Debut in Albany 4 registrants, only 2 showed up
 - 3. Suffolk & Rochester
 - a. Suffolk had 26 officers in attendance including Suffolk PD, which is the 11th largest PD in the country. That said, many depts. not in attendance with only one (Hempstead) from Nassau county.
 - b. Rochester had very positive response, although only 11 attendees with 5 from RPD.
 - ii. Training schedule (attached)

- 1. Initial numbers show a decent amount for Erie county, Dave met with Erie county police chiefs yesterday, rec'd well. Expect more local from this.
- 2. Maj Benziger indicated State police is looking at December.

iii. Outreach

- 1. DCJS training schedule handout goes out across state. If certain officers don't open it, may not see we're presenting. FR DAT has started to send out its own announcement via Constant Contact.
- 2. Suggestions
 - a. Send out numbers/statistics to departments about their community's local makeup of people with disabilities so they are the magnitude of population.
 - b. Reach out to other key players, not just first responders (parent groups, community organizations, etc.) reach out to departments about training from a community standpoint.
 - c. Advisory council members pass on to correspondents
- 3. Working on ambassador/follow-up system to post for networking
- iv. Tracking building log to include every officer trained, follow-up on the trainings they've conducted.
- v. NYS Chiefs of Police instructor Mark Spawn moving cross country
 - 1. Podcasts 4 developed
 - 2. Online-Reviewing this
- vi. NYS Sheriffs Assn
 - 1. Sheriff Jim Voutour building connections with Sheriff's Association, had Dave on agenda at 1/17 statewide conference. Led to much interest by several sheriffs.
- b. Fire little less than two full days of training
 - i. Train the Trainer complete
 - ii. Feb 5-6 debut 14 participants in Rome, NY, all from OPWDD Fire safety division made mandatory by administration.
 - 1. Length of program comments being too long (summary attached)
 - a. Cannot condense material (cuts have already been made); look to modularize it
 - b. Discussed creating certifications for completion of each portion
 - iii. NYS OFPC Chief Dickinson meeting Chief is on board to send out messages and inquire about looking into conference in June
 - iv. Future TTT sessions
 - 1. March 26-27 debut to public 3 registrants so far. This will serve as a mini-pilot to see how community/VF depts. respond.
 - 2. Would like to present at NYS Fire Chiefs conference in June, any assistance welcome.

- c. EMS introduced at FASNY conference Feb 2 in Suffolk county, 30 signed up to become trainers
 - i. Outreach look into becoming involved directly with EMT core training
 - ii. On-line training Janine has begun review/construction of this for EMS.
 - iii. FASNY 2013, Dave will also be at the March 2 conference at the State fire academy.
- iv. CME credits DOH EMS accepts our course as 8 non-core credit hours Website (www.fr-dat.com)
- a. Additions will add disability stats when collected

IV.

- i. In the News (under About Us tab); this will have any media that FR DAT has been in. so far, one news coverage and four newspaper articles.
- ii. Articles (under About Us tab); these are articles of interest for first responders, be it best practices, good deeds, or info on disability topics that would be of interest (i.e autism and wandering, abuse of IWDs)
- iii. Training sites (under Calendar tab) map, dates to see where were and where we will be training.
- iv. OPWDD (under Individuals/Family/Service Providers tab) work in progress,
 want to include OPWDD contacts and fire safety representatives
- V. Trainer Network people interested can apply but must be screened (not strict criteria), these are IWDs, parents, and service providers who may be interested in accompanying a first responder who would like someone to join them when they train. This would be disability specific.
- VI. Sustainability year 4 & 5 extension was approved by the DDPC, awaiting the Comptroller's OK.
 - a. Fee for service when outside of NYS first responders request training.
 - i. Training from NU If a dept. would like Dave to come to train (not TTT), there would be a fee.
 - 1. National training being looked at with possible June 12-13
 - b. Product outside of state interest in purchasing the product
 - i. National Crime Victims Network submitted to present at conference
 - ii. DDPCs article put into national newsletter, looking to reach out to all DDPCs across the country
 - c. Corporate sponsors needs to be brought to forefront, finalizing fees, looking into volunteer FDs and insurance companies' interest in getting their name in front of them.
 - d. Grants met with NU writers who will be keeping a watch for grant opportunities. There is a lot of potential with emergency mgmt.
 - e. NU Institute progress delay in moving fwd but interest seems to still be prevalent.
- VII. Town Hall Training March 19th at NU; developing comprehensive spreadsheet of municipalities & ADA coordinators to include those that have been trained
 - a. Year Three (2013) approved, funded by Trust
 - i. 9 training sites TBD had one in Suffolk Co., Rochester interested

- ii. Pike County, PA contacted and is looking into bringing THT and FR DAT
- iii. ILC mini-grant proposal through NU to ILCs for Town Hall Training, this is being discussed with the Trust. It would encourage ILCs to continue the drive to carry out THT principles.
- iv. Year 4-5 preliminary discussion on extension.
- b. National ADA Coordinators conference April, tracks on LE/municipalities/higher education

VIII. Other

- a. Brooklyn Senator Adams promoting cause, proposed legislation (Bill S2413) to require training
 - i. We do not support mandatory training AT THIS TIME (not enough funding in depts. to pay for it); want acceptance without "throwing it down their throats"
 - ii. Will contact office to put us on Senator's radar
