NU FRDAT Enhances Relationship with TBI Advocate & State Office

In a continuing effort to improve and enhance materials, resources, and information, NU FRDAT has partnered with the **New York State Department of Health Traumatic Brain Injury Division** and TBI advocate and survivor, Brent Feuz. This partnership has led to:

- A Firefighter/EMS Disability Awareness Train the Trainer conducted May 10-11 in Albany, NY, funded by NYS DOH TBI. Attendees received a comprehensive curriculum on TBI.
- A video featuring Brent, whereby he candidly discusses his TBI specific to medical providers, law enforcement, firefighters, and EMTs. This will be available later this month.
- Dissemination of Brent's **Guide to Approaching Mild/Moderate Brain Injury in New York State**. In support of NU FRDAT's expansion, Brent now has developed a manual that can be used nationwide.

NU FRDAT Attends 28th Annual DD Day



What is considered the largest single day conference on developmental disabilities in America, **Western New York Developmental Disabilities Awareness Day (DD Day)** was held in Niagara Falls, NY on May 26. Over 1,500 individuals attended the conference, including Megan Bomgaars from A&E's hit show *Born This Way*.
